

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.graceowsleydressage.com and Grace Owsley Dressage and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Grace Owsley Dressage include www.graceowsleydressage.com. The Grace Owsley Dressage website is a Business and blog site. By using the Grace Owsley Dressage website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Grace Owsley Dressage may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- If you are over 18

Grace Owsley Dressage may also collect anonymous demographic information, which is not unique to you, such as your:

- Age

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Sharing Information with Third Parties

Grace Owsley Dressage does not sell, rent or lease its customer lists to third parties.

Grace Owsley Dressage may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique

personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Tracking User Behavior

AFS Analytics measures website traffic and analyzes user behavior. It tracks how visitors interact on the website.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Grace Owsley Dressage. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Grace Owsley Dressage website.

Use of Cookies

The Grace Owsley Dressage website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
